As you are aware, this Ministry provides support to voluntary organizations in the disability sector for various types of projects under the Deendayal Disabled Rehabilitation Scheme(DDRS). This is to request for proposals for grant-in-aid for 2011-12 under the Scheme.

2. In this connection it is informed that the notional allocation for the State of \_\_\_\_\_\* under this Scheme for the year 2011-12 has been fixed at Rs. \_\_\_\_\_\*. The notional allocation has been worked out on the basis of the committed as well as the estimated liability of all the ongoing proposals of your State apart from the population of the disabled persons in the State in low demand states.

3. Proposals from voluntary organizations for grants-in-aid for 2011-12 under DDRS, duly recommended and prioritized by the Multi-disciplinary grant-in-aid Committee (GIA Committee) of your State, are to be forwarded to this Ministry in a consolidated manner within the notional allocation indicated above. The signed minutes of the meeting of the GIA Committee and the proposals in the prescribed format, indicating the inter-se priority, should be positively sent by **30<sup>th</sup> June, 2011**.

4. It is the policy of the Government to give priority to ongoing cases in releasing grants. You are, therefore, requested to consider ongoing cases first and recommend them based on their suitability to receive the grant.

5. I shall be grateful, if you could kindly send us consolidated proposals under the Scheme latest by **30<sup>th</sup> June, 2011**, keeping in view the notional allocation for your State.
