

Minutes of the Screening Committee meeting held on 19.11.2007 to consider the new proposals for grant-in-aid to the Non-Governmental Organizations in regard to the schemes being implemented by the Ageing section.

A meeting of the Screening Committee was held on 19th November, 2007, under the Chairmanship of Dr. Arbind Prasad, Joint Secretary (SD) to consider the new cases under the two schemes of the Ageing section. Sh. M.M. Sabharwal and Ms. Rinku Jayant, members of the Screening Committee were also present in the meeting.

2. At the outset, the Committee was informed about detailed guidelines streamlining the procedure for sanctioning of grant-in-aid issued vide Ministry's letter F.No.1-13/2006-Cdn.dated 21-3-2007. As per these guidelines, the Ministry had already indicated State wise notional allocation of funds during 2007-08. The state-level " Grants-in-Aid Committee for supporting the voluntary organizations " had been constituted in each state. The Committees of various State Governments had already met and forwarded the new proposals for consideration during this financial year.

3. The Committee was further informed about the position of fund availability in respect of various states after the consideration of the continuing proposals. In case of some State Governments, the funds under notional allocation had already exhausted, though many continuing proposals were still pending to be taken up. So, in such States there was not enough scope of sanctioning new projects. However, the Committee felt that even in such States, the projects should be supported in the districts not adequately served.

4. In those states, where it was not possible to take up all the proposed projects in any district due to non-availability of adequate funds, they were approved according to the priority lists sent by the State Grants Committee. However, in some cases for covering the unserved areas, projects lower in the priority list were also taken up. The Committee further noted that though the proposals had been screened by the Grants-in-aid committees constituted by the State Governments, yet many proposals were deficient in certain documents. So, such proposals were approved subject to the Organization making available all the necessary documents on immediate basis.

5. It was also noticed by the Committee that though according to the population of older persons, large amount of funds were allocated on notional basis to States like Bihar, Gujarat, Maharashtra, Rajasthan etc., yet the presence of the projects under the scheme was negligible in these States. Further, most of the proposals received from the unserved Districts of these States were proposed projects. It was deliberated that unless some exception was made in such cases, these states will continue to remain unserved and the purpose of making allocation of funds State wise will be defeated. It was therefore, decided by the Committee to consider such proposals from unserved areas/States, if the concerned Organizations had seen associated with the activities pertaining to welfare of older persons.

6. The Committee were informed that all the new proposals (total: 236 cases) received from the State Governments by 24-10-2007 had been included in the lists presented to the Committee. The committee examined all the cases presented before it in light of the facts mentioned above. The new cases (total: 172 cases) recommended by Manipur, Karnataka, Nagaland, Assam, Gujarat, Kerala, Maharashtra, Hariyana, Rajasthan, Chhatisgarh, Uttar Pradesh, Himachal Pradesh, Mizoram, Tamil Nadu and Madhya Pradesh were taken up. The proposals received from the State Governments of Orissa and West Bengal (Total: 64 cases) could not be taken up.

7. After considering the notional allocation of the state; number of ongoing projects and their district wise distribution; availability of necessary documents like inspection report, State Government's recommendation and priority lists, annual report, audit report, previous experience etc., the committee recommended a total of 131 new cases under the Scheme **Integrated Programme for Older persons** as per details given in Annexure-I.

8. The committee decided to send all the other 38 cases (details in annexure-II) to the concerned State Government for removing their deficiencies and their reconsideration by the Grant-in-aid committee for unserved districts of their respective State/UT. Some of the deficiencies

noticed by the committee in the cases to be sent back to the State Governments have also been recorded in the remarks column of the Annexure-II.

9. As regards the cases for the construction of old age homes/multi-service centres for older persons (Non-Plan scheme), proposals for GIA for construction of Old Age Home, which were received up to 24-10-2007, were placed before the Committee. The Committee was also informed that the Scheme was being revised to a Plan Scheme and it would take some time before the new scheme comes into force. Taking into account various factors, the Committee decided to sanction all the 3 cases (indicated in Annexure-III) with the condition that these will be take up after the revised scheme is notified.
