

Minutes of the meeting of the Screening Committee held on 13-14.06.2011 to consider the fresh project proposals under the Scheme of the Integrated Programme for Older Persons (IPOP)

The meeting of the Screening Committee to consider fresh proposals under the Scheme of the Integrated Programme for Older Persons (IPOP) was held as per the schedule on **13-14.06.2011**. The meeting was held under the Chairmanship of Shri Abhilaksh Likhi, Joint Secretary (Social Defence), Ministry of Social Justice & Empowerment in Room No. 610, Shastri Bhawan, New Delhi. Shri M.M. Sabharwal, Smt Shanthi Ranganathan and Smt Reena Garg who are members of the Screening Committee attended the meeting. Shri O.P. Dogra, Deputy Secretary (DP), Shri J.K. Sahu, Under Secretary (Ageing) and Smt Anupama Datta, Helpage India were also present to render necessary assistance to the Committee members.

2. At the outset, the Committee was informed about the budget allocation for 2011-12 and the notional allocation fixed for the States/UTs for 2011-12, committed liability for funding existing ongoing proposals and number of new proposals recommended by the Screening Committee during 2010-11, the recommendations for which will remain valid for release of grant in the current financial year. The Committee was also informed that as per the policy decision contained in the Ministry's Office Order No.1-31/2006-Cdn. dated 05.09.2008, recommendations of the State GIA committee for new projects remain valid for the financial year following the year in which they were received and recommendations of the Screening Committee within the Ministry remain valid for one year following the year in which they are recommended. However, recommendations of the State/UT Governments along with inspection reports for the current year are required for releasing of grant to any new proposal under the Scheme.

3. Recommendations of the State Governments for new cases for the year 2011-12 have not been received from any State Government as on the date of the meeting of the Screening Committee. There were 255 new proposals for the year 2010-11 recommended by the State Governments of Andhra Pradesh, Bihar, Chhattisgarh, Delhi, Haryana, Himachal Pradesh, Jharkhand, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Nagaland, Orissa, Punjab, Rajasthan, Tamil Nadu, Tripura, Uttarakhand, Uttar Pradesh and West Bengal received in the Ministry after the last meeting of the Screening Committee held on 30-31.12.2010. These proposals could not be considered during 2010-11 as no meeting of the Screening Committee could be held in the last quarter of the financial year 2010-11. These proposals were placed before the Committee in the meeting held 13-14.06.2011 for consideration and recommendation.

4. Copies of the guidelines of the Scheme and the Statement showing State-wise notional allocation for the year 2011-12 was provided to the Committee for reference.

5. The Committee decided to consider the proposals keeping in view the guidelines of the Scheme, notional allocations for the States for the year 2011-12 vis-a-vis State-wise committed liability for funding of ongoing projects under the scheme and the recommendations of the Screening Committee during 2010-11 which can be considered for release of grant during 2011-12. The Committee also decided to give priority to un-served and under-served districts/areas and to innovative projects in the revised Scheme w.e.f 1.4.2008 while considering the project proposals for recommendations. Accordingly, keeping in view the requirements of the Scheme, the Committee considered the proposals and made recommendations with observations for calling proper documents, wherever found it necessary.

6. The Committee, during examination of the above fresh proposals recommended by the State Government observed that many of them were incomplete in many respect and unsuitable for recommendation. The Committee, therefore, decided that such proposals be returned to the respective State Governments with the advice to send complete proposals for consideration in the next meeting. The list of proposals which were placed before the Committee is enclosed at Annexures. The reasons for which the proposals have not been recommended by the Committee have been mentioned against the name of the organizations.

7. The Committee could not consider the proposals of Maharashtra, Uttar Pradesh and Tamil Nadu due to paucity of time and decided to consider these proposals in the next meeting of the Screening Committee. The Committee decided not to consider the proposals for Regional Resource and Training Centres (RRTCs) in this meeting as the parameters for RRTC are different.

8. State/ UT-wise position of the recommendations of the Screening Committee after taking into account the procedure/criteria mentioned in para 5 above are annexed. Proposals recommended by the Screening Committee are detailed below.
